Footnotes

JOHN'S CATNIP got sent over towards the inside coming to the end of the backstretch, scurried into contention, with a rail run from the top of the bend to midpoint, lost its footing over the sloppy going proceeding to get angled out from that point, wound up in the five path by the three-sixteenths pole, took charge, then drew off, kept busy to the end. PERSKY'S SPIRIT got placed at a slight distance from off the rail, rated kindly stayng range of the disputed pace, got asked for a response as the stretch drive began, altered course towards the four path in two stages, rallied well enough to garner the place, although clearly unable to keep pace with the winner. BEA BEA vied for control from the two path, put to a hand ride by the rider, tired after going a half. OVERDRIVE three wide midway on the turn, was in path seven in midstretch, had some late gate. FROSTY APPEAL three wide midpoint on the turn, was in path six in midstretch, made no impact. RESCUE CAT disputed the pace from the three path on the turn while in hand, gave way. SHE'S JESSES GIRL put to a ride early down the backstretch, chased futilely from the two path. SHOW RIVER came away last, after lunging out at the break, rushed up into midpack, stepped onto the turn from the two path, was put to encouragement by the three-eighths pole, tired. GALWAY GIRL had a ground-saving journey and faded.
