

## Footnotes

AVA'S KITTEN four then three wide in range of the leader in hand, got set down spinning three wide for home, drifted four wide three-sixteenths out, rallied with a good kick to issue a challenge knocking heads with SUNNYSAMMI through the final eighth and just got up in the last jump to score. SUNNYSAMMI coaxed from the gate, raced three then two wide between foes in closest aim of the leader in hand until taking over command roused spinning just off the inside for home, dug in under a drive dueling through the final eighth and was nailed in the very last jump in a game effort. RUMBLE DOLL saved ground near the rear in reserve until put to a ride five-sixteenths from home, cut the corner into upper stretch, angled out a furlong out to the two path before shifting back to the inside just inside the sixteenth marker sawing off the backing away JUSTA LADY and forcing that rival to check, surged late and missed on the wire the innermost of a trio to hit the finish together. LADY KREESA coaxed from the start, chased two to three wide from mid pack coming under encouragement five-sixteenths from home, swung three to four wide into upper stretch, rallied in tandem with ORIENT HARBOR, came out slightly under a near sided stick a sixteenth out leaning on that foe for a stride, had the rider switch to an off sided stick quickly to correct it and just prevailed for the last major share. ORIENT HARBOR three then two wide near the rear, got asked and angled five wide at the head of the stretch, rallied in tandem with LADY KREESA to her inside, got brushed and leaned on for a step just inside the sixteenth marker while offering up a mild bid and was headed for the last major

share on the wire. BRINKLEY coaxed from the gate, chased the pace along the inside, got set down spinning just off the inside for home, offered up a mild kick but was outkicked through the stretch. JUSTA LADY coaxed from the gate to establish the front, got put to a good hold showing the way from the two path and then along the inside from the seven-sixteenths, grew keen at intervals eager to go on, got given some rein nearing the quarter pole, was headed cutting the corner into upper stretch, fought on under a drive a furlong out, was in the midst of backing away when forced to check as RUMBLE DOLL darted to the inside just inside the sixteenth marker and faded through to the wire. SUMMER READING chased three to four wide under a ride from the five-sixteenths, angled six wide into upper stretch, offered no response. There was a Stewards' Inquiry focusing on the brushing incident at the sixteenth marker. As a result, LADY KREESA was disqualified from fourth and placed fifth having been deemed to have caused interference to ORIENT HARBOR substantially enough to cost a placing position.
