ENCHANTERESSE (IRE) impeded TALLER SISTER when bearing in soon after the break, saved ground, disputed the pace, opened a clear lead in mid stretch and held sway under pressure. GLORIOUS CHANT stalked the pace, had room along the rail in the stretch and flattened out. LADY DYNA, three wide both turns, eased out in upper stretch and had a late rally outside foes. TALLER SISTER stumbled after being bumped and forced in by ENCHANTERESSE soon after the break, angled to the five path leaving the far turn and rallied. CAVORT steadied lacking room near the three eighths pole. PAULINE'S PRIDE had a four wide move entering the stretch then flattened out. MAGICIAN'S VANITY, steadied when bumped by TALLER SISTER soon after the break, raced four wide entering the stretch and failed to rally. CLUTCHINGATSTRAWS (GB) saved ground the first turn, was eased back entering the backstretch, remained along the rail and steadied lacking room in mid stretch. CHANEL NUMBER ONE, three wide the first turn, dueled two wide on the backstretch and far turn then gave way in upper stretch. RIGHTEOUS INTENT was outrun. MOVE OVER HONEY, five deep the first turn, chased the pace and was taken up in tight quarters leaving the far turn. Following a stewards' inquiry, ENCHANTERESSE was disqualified and placed fourth.
