GOUYEN pulled and dueled inside rival then steadied midway on the hill and took back, stalked inside, came out and bumped a foe leaving the dirt crossing and rallied under urging to gain a short lead in deep stretch then held between foes. TALE OF PAPA NICK dueled outside the winner then inched away and angled in, set the pace inside, fought back along the rail in the final furlong and continued gamely to the wire. SIDEPOCKET RUN broke slowly, settled off the rail, came four wide into the stretch and finished well four wide on the line. CHAULK O LATTEY saved ground stalking the pace, came out in upper stretch and rallied between horses late. DESERT STEEL pulled some and stalked a bit off the rail then outside a rival, was bumped three deep into the stretch and could not quite summon the necessary late kick. AN UNUSUAL GROUP settled a bit off the rail, angled to the inside in the stretch and had a mild late bid. FRANDONTJUDGE stalked outside a rival then between horses leaving the hill, came out in upper stretch, angled in some in midstretch and lacked the needed rally. WARRENSDOLLARSIGNS chased outside then three deep leaving the hill and into the stretch, steadied off heels in upper stretch, drifted in and weakened. Following a stewards' inquiry, GOUYEN was disqualified and placed fifth for interference into the stretch. Rail on hill at 14 feet.
