GIMLET was allowed to settle back off early pace, steadied back sharply leaving three eighths pole, regained momentum and split foes just past the quarter pole, came out five wide entering top stretch, came under right handed urging, swept by and finished in hand. TERRY'S CHARM was unhurried running through the backstretch, made move between rivals three furlongs out, hustled up three wide upper stretch and finished second best. WHAT POWER set a pressured pace then began to duel for the lead, battled back racing along inside of AT THE READ, was no match for eventual winner, came out and made slight contact with aforementioned rival and held show. AT THE READY tracked the pace racing along the outside, began to duel along outside of WHAT POWER, dug in along outside of rival, was no match for eventual winner and got brushed by aforementioned rival in deep stretch. LUCKY KITTEN stalked and saved ground along inside, cut the corner entering the lane then moved up close contention along rail, could not sustain needed bid and evened out. FIRE ON FIRE raced five wide in the first turn, was rated along the outside in backstretch, came under a ride then failed to move on in the lane. GEORGE CROSS raced off the early pace, came under a ride and failed to kick on. MONGOLIAN SUNDAY pressed the pace in the backstretch, weakened in far turn and had no response in the lane. JOCKEY OF #6 LODGED CLAIM OF FOUL AGAINST #4 FOR INTERFERENCE IN LATE STRETCH, STEWARDS RULED NO CHANGE
