Supplementary nominations may be made at the time of entry Wednesday, March 30, 2016 by payment of \$3,750 each (includes all fees). \$75,000 Guaranteed plus \$25,000 KTDF for KTDF eligibles only. Monies to be divided 62% to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. KTDF funds correspondingly divided providing a KTDF eligible horse finishes in an award position. Weight: 124 lbs. Non-winners of a Sweepstakes at a mile or over allowed, 2 lbs.; A Sweepstakes, 4 lbs.; a race other than maiden or claiming at a mile or over since December 5, 2015, 6 lbs. Starters and riders must be named through the entry box by the usual time of closing. This race will be limited to twelve starters with two also eligibles. Preference to start will be given in the following order: Graded/Group Stakes Winners (in order I-II-III), stakes winners, then highest career earnings. All Horseshoe Casino Cincinnati Spiral Stakes nominees are automatically nominated to this race. Failure to draw into the race cancels all fees. Closed with 17 nominations on March 24, 2016 plus an additional 186 that were nominated to the Horseshoe Casino Cincinnati Spiral Stakes. **Footnotes**

HE'LL PAY settled in hand, worked his way to the inside after a half, found a seam along the rail and joined the vanguard nearing the quarter pole, seized command entering the stretch, and held sway while floating out a bit under left handed urging. VIRTUAL MACHINE stalked the pace four wide, ranged up to engage the leaders on the second turn, poked his head in front with five-sixteenths to run, dug in to meet the bid of HE'LL PAY leaving the second turn, was carried out through the drive and was unable to match strides. RATED R SUPERSTAR was allowed to settle, advanced between horses, angled out and loomed a danger, but flattened during the drive and settled for the show. GIMLET tracked the pace three wide, took over after a half, was collared between rivals midway through the second turn, but clipped heels a quarter mile out and weakened. SCHOLAR ATHLETE settled saving ground, took closer order through the second turn, got through entering the stretch, but faltered in the drive. TRIPLE CREEK broke slow, was unhurried into stride, circled five wide

and finished with a mild advance. KEYSTONEFORVICTORY bobbed at the start, was allowed to settle, made a belated improvement, but was never a factor. ALTA RITA passed only the tiring ones. BANDAR was forwardly placed four wide, but tired before going six furlongs. BACK TOGETHERAGAIN sent clear to set the pace, was headed after a half and gave way readily thereafter. LEMONDROP BOLD contended six wide to the second turn and dropped out. The jockey of GIMLET lodged an objection against HE'LL PLAY for alleged interference near the quarter pole, but following the Stewards review there was no change to the order of finish.
