**Footnotes**

DICKINSON stalked the pace early along the three path, was off the rail entering the lane, had no room in the upper stretch, altered out for running room to about the six path, once clear had a late surge and was just up at the wire. LADY ELI steadied a bit in the first turn, steadied again inside the seven sixteenth pole, shifted into the four path entering the lane, made a bid three wide nearing the eighth pole while lugging out a bit, edged past and inched clear inside the sixteenth pole but was caught at the wire. QUIDURA (GB) chased the pace early along the four path, fanned into the five path in the far turn, made a bid in the stretch but flattened out late in the drive. KITTEN'S ROAR trailed the field early from the four path, fanned into the eight path in the far turn, rallied in the stretch with a late gain in the final stages. GOODYEARFORROSES (IRE) was back early along the four path, fanned into the seven path in the far turn with a belated gain in the stretch run. TIME AND MOTION was well placed early from the four path, swung into the six path in the far turn and leveled out late in the stretch drive. ILLUMINANT tracked the pace early along the four path, shifted into the three path in the far turn, led the field in the stretch from between horses but faltered late in the drive. CATCH A GLIMPSE set the pace early, was on the inside entering the lane and gave way late in the stretch run.
