

ANITA PARTNER (IRE) chased between horses then outside a rival, came three deep into the stretch, angled out in upper stretch, rallied under left handed urging to bump the runner-up a sixteenth out then surged between foes late. BETTY DRAPER settled outside then off the rail, continued outside leaving the hill and four wide into the stretch, was bumped a sixteenth out but continued willingly outside foes. CANDY BOSS had good early speed and dueled inside, kicked clear on the hill, drifted out into the stretch then drifted in, drifted out again under left handed urging in deep stretch to bump a rival and was narrowly outfinished. LONGSTOCKING chased three deep then outside a rival, came out five wide into the stretch, rallied to bid between foes in deep stretch, was bumped between rivals late and also was outfinished. PLASTERED between horses early, chased a bit off the rail, split rivals in upper stretch, continued inside and lacked the needed late kick. KHALEESI (BRZ) four wide early, stalked three deep, came four wide into the stretch and lacked the necessary response. DISCATSONTHESQUARE stalked between horses, steadied while coming out into the stretch and steadied again off heels in upper stretch and did not rally. TALE OF PAPA NICK dueled three deep then stalked outside a rival, came out into the stretch and weakened. DULCE ARABE (CHI) had good early speed and dueled between horses then stalked inside leaving the hill and also weakened. ASHLEY'S SASSY settled outside a rival then saved ground off the pace, steadied in tight midway on the hill, continued inside into the stretch and lacked a rally. LITTLE VOICE saved ground stalking the pace, fell back in the stretch, drifted out late and weakened. Following a stewards' inquiry and a claim of foul by the rider of LONGSTOCKING against CANDY BOSS, the latter was disqualified and placed fourth for interference in deep stretch while ANITA PARTNER was disqualified and placed second for interference passing the sixteenth pole. Rail on hill at 7 feet.
