MAJESTIC HARBOR was allowed to settle, circled five wide through the second turn, forged command with a quarter to run and edged clear. KNIGHTS NATION settled saving ground, moved into striking distance through the second turn, swung six wide and finished well for the place. PATRIOTICANDPROUD settled in hand, took closer order three deep, bid between horses entering the stretch, was caught in tight and steadied near the three-sixteenths pole, flattened and settled for the show. SHINING COPPER opened clear and angled in to set the pace, was headed midway through the second turn and gave way readily. SERUNI was close up three wide, drifted out entering the stretch tightening up PATRIOTICANDPROUD and retreated. The Stewards conducted and inquiry into the run into the lane, but following the review made no change to the order of finish.
