**Footnotes**

MY BUCKY'S BOY was rated off the top two leaders in the backstretch, sat patiently then roused along rail entering head of lane, dueled along the inside of GAULTIER, slightly drifted a couple paths and remained strong to the wire. GAULTIER (FR) set a pressured early pace, dueled along the inside of CAPE DYNASTY, continued to battle entering top stretch, took on added challenged of eventual winner, continued to fight for late position then lacked a final kick. BENEFICIARY was rated near midpack in the backstretch, moved up closer approaching the final turn, lacked racing room upper stretch, shifted out and finished with good kick. CAPE DYNASTY pressed the pace in the backstretch, dueled along the outside of GAULTIER in far turn, continued just off top two leaders in final furlong then steadied slight late. HOPETOWN was keen in the first turn and into the stretch, lost position leaving the backstretch but continued steady bid, needed more for late impact. GUN STREET raced off the early pace, edged up bit closer along the outside, moved out wider upper stretch then lacked needed rally to make impact. PONTIFICATE was unhurried racing in or near the back, came out in the final turn and had no late response. DAWN PATROL raced in or near the back and failed to move into contention. RAPTOR raced midpack in the backstretch then weakened in the far turn. CZARMO raced off the pace and failed to move on in the lane. THE JOCKEY OF #8 LODGED CLAIM OF FOUL AGAINST #4 FOR INTERFERENCE IN LATE STRETCH, STEWARDS RULED NO CHANGE
