Footnotes

BRICKS AND MORTAR settled in midpack two to three wide for six furlongs, rallied four wide into the stretch and closed steadily to draw clear after catching SECRETARY AT WAR inside the eighth pole. BROOKLYN BOBBY was taken off the inside leaving the first turn, raced well within striking range three wide around the far turn and finished with good determination to get second. SECRETARY AT WAR broke sharply and prompted the pace outside MEARS for six furlongs, took over into the stretch, was overtaken by BRICKS AND MORTAR, then lost the place late while weakening slightly. CICERONE saved ground early, raced two to three wide on the far turn and lacked a solid late response. ON JOHN was forwardly placed two wide early, remained in striking range inside around the far turn and lacked a bid. COUNTY COURT was two to three wide early, moved off the rail approaching the stretch and was no threat late between horses. RIND was away slowly and far back three to four wide on the first turn, made up some ground three wide around the far turn and finished evenly. NOT IN CHARGE saved ground and failed to become a factor. MEARS was quickly in front on the rail, set the pace to late on the far turn and gave way after being overtaken. FRENCH COMMAND was three wide around the far turn toward the rear and made no headway. BAYFUL was always far back and steadied toward the inside behind other stragglers on the far turn. UNCLE WILLIE was three wide on the turns and outrun.
