WAR CORRESPONDENT settled off the leaders early, saved ground through the second turn, angled out approaching the stretch, responded to steady urging and wore down ARIPEKA in the closing yards. ARIPEKA dueled for the lead from the inside with EXCAPER, disposed of that rival after going three-quarters, opened a clear lead into the lane, remained safe through mid-stretch but could not resist the winner late. GRAND TITO raced off the pacesetters early, moved far wide through the second turn and finished with good late energy. DRAMEDY showed no early foot, raced far wide through the second turn and finished with ARIPEKA and gave way after going six furlongs. LOCHTE settled off the leaders early, moved outside through the second turn and finished evenly in the drive. BREITLING FLYER pressed the pace from the outside and weakened after going a half.
