LAUR NET settled off the pace, saved ground on the turn, came out in upper stretch while steadily advancing, split rivals past the sixteenth pole to surge forth. CHURCH ROAD settled off the pace near the inside, angled five wide past the quarter pole, bid steadily through the stretch to get up for second but outfinished by the winner. BELLA ANN moved four wide through the turn, struck the lead briefly in upper- to mid-stretch but lacked the needed late kick. DOGGERWINII moved forward under mild coaxing to set the pace inside, resisted challengers and kept on but was not good enough. CANETTE was urged along three wide but went evenly late. FREAKIN AMAZING was in touch with the leaders four wide and outside then dropped back shifting in. WORLD PEACE moved up to track the leaders inside then was empty in the stretch.
