NATURAL WONDER contended inside CANETTE, came out a bit entering the stretch, edged clear under steady right-handed pressure. SHOWERSOFBLESSINGS stalked the pace from outside, bid three wide leaving the turn, was hard-ridden and got the nod for second. KINGSTON TERRACE raced in behind the early leaders, came into the stretch in the two path, shifted in past the furlong marker and gained steadily and slowly but just missed the place. CANETTE pressed the pace, contended into upper stretch and had no extra late. WORLD PEACE went four wide on the turn and had no final kick. MI FIORI chased inside, was checked when in tight about the eighth pole. BEE DEES BID raced outside and had no bid. FOLLOWING THE RACE WAS A STEWARDS' INQUIRY INTO THE STRETCH RUN AS WELL AS AN OBJECTION BY THE RIDER OF MI FIORI AGAINST KINGSTON TERRACE ALLEGING INTERFERENCE. UPON REVIEW THE LATTER WAS DISQUALIFIED AND PLACED SIXTH BEHIND THE FORMER.
